Team Member Agreement

Being a Global Outreach short-term team member is a privilege and a responsibility. Together with my team, Team Leader, our host missionaries, and Global Outreach International, we covenant to the following:

1. Our Team Leader and our host missionaries are our authorities and guides. We will learn from them, and listen to them, and follow their example of service, love, and contextual awareness. When they set boundaries, we will respect them.
2. Our team members will respect and love one another and put each other's needs above our own. We will set respectful, contextually appropriate boundaries in how we dress, speak, and act towards one another, considering the standards of modesty, caution, and chastity. We will always defer to our Team Leader and our host missionaries in these matters.
3. As a general rule we agree to set aside personal preferences and abstain from all forms of alcohol and tobacco use. We recognize that this may vary by context so we commit to following our Team Leader's guidance and obeying all applicable laws.
4. The costs of this trip are ours to bear. We have planned ahead and are prepared for our needs.
5. We recognize that any funds given through Global for this trip are considered donations to Global Outreach International. While in some cases they may be returned as a donation to our sending church, we do not expect ministry refunds to be returned to individuals. This is separate from individual spending money (if applicable).
6. I commit to reading the Global Outreach Mission Statement and Statement of Beliefs at www.globaloutreach.org/about. I commit to speaking and acting within these boundaries for the entirety of my participation on my team, recognizing that as part of this team, I represent Global Outreach.

Liability Release

I, the undersigned, am aware of the hazards and risks to my person and property associated with serving in a mission's capacity, including, but not limited to, death or injury by accident, disease, war, terrorist acts, weather conditions, inadequate medical services and supplies, criminal activity, and random acts of violence. I accept these risks in full and acknowledge that it is solely my responsibility to decide on and obtain any applicable insurance coverage. I voluntarily assume all risk of death, injury, and/or illness, and release Global Outreach International and all its affiliated volunteers, directors, staff, and missionary personnel from any and all liability arising in any connection with my participation on this trip or my association with Global Outreach. I recognize that these risks have always been associated with missionary service (2 Corinthians 11:23-28).

I expressly waive any defense to the enforcement of the commitment arising from a claim of lack of consideration and warrant that this commitment constitutes a legal, valid and binding obligation upon me enforceable against me in these terms. I expressly agree that this Liability Release is intended to be as broad and inclusive as permitted by law. I HAVE CAREFULLY READ THE FOREGOING, I UNDERSTAND IT, AND I VOLUNTARILY SIGN THIS RELEASE AS MY OWN FREE ACT.
